Sterling Cunio: I was telling somebody earlier that it's it's an emotional roller coaster because you get excited. But at the same time, you know, I've won before and then it gets took back. Plus too, you don't want to have to explain the complexities to everybody, because people that don't understand the legal process, they hear "release hearing" and they asking me what I want for dinner. Right? They like planning a dinner I'm like, hold on, hold on, you know what I mean? Like they have 30 days to decide whether or not they're going to appeal. And then if they appeal the decision up to the Ninth Circuit, then that could be another year or two.

Professor Melissa Buis: Well, imagine if the state didn't spend so much money just fighting you having the chance at parole.

Sterling Cunio: Yeah.

Professor Melissa Buis: And instead invested that money in working with victims and getting to true healing.

Sterling Cunio: As exciting as it is for me is, there's also.... it's it's traumatic for, you know, for the people that I hurt, for the people that, you know, shot, I mean, their families like, every proceeding, they got to go to.
